

## Goffs UK Premier Prizes

### Terms & Conditions

In addition to the prize money, connections of the Goffs UK Harry Beeby Premier Yearling Stakes winning horse will also win the additional prizes set out below, subject to the terms and conditions set out below.

The winning owner/owners will receive a voucher to the value of the average price achieved at the previous year's Premier Yearling Sale for use at the Goffs UK Premier Sale:

- The value of the voucher will be determined by the average price at the previous year's Premier Yearling Sale and as displayed on the Goffs UK website (for example, the average price at the Premier Sale in 2021 was £40,795 and the value of the voucher to be awarded in 2022 is £40,795).
- The voucher can only be redeemed at the Goffs UK Premier Sale in the same calendar year in which it is won.
- The voucher will be awarded to the owner/owners of the winning horse as registered by Weatherbys as at the day of the race. In the event of a dead heat where more than one horse is confirmed as the winner, the voucher will be split equally between the owner/owners of the confirmed winners (for example, if there are two winning horses the owner/owners of each horse will receive half of the value of the voucher).
- If the winning horse is owned by a partnership of two or more registered owners and not all registered owners wish to redeem the voucher together, the voucher may be split between the registered owners in accordance with the proportions in which they own the horse as registered by Weatherbys.
- Where the voucher is split between multiple owners, the total value of vouchers offered will never exceed the value of the average price achieved at the previous year's Premier Yearling Sale.
- The voucher is non-transferable and can only be redeemed by the registered owner/owners of the winning horse as registered by Weatherbys.
- The voucher can only be redeemed against one horse and cannot be used against multiple purchases.
- Where a horse is purchased (or part-purchased) using a voucher, the winning owner/owners must retain ownership of the horse until at least 1 June of the year following the purchase of the horse. Failure to adhere to this condition will require the owner/owners to return a sum equivalent to the value of the voucher (or part thereof required to purchase the horse) to Goffs UK.
- The voucher has no monetary value and cannot be exchanged for cash in the event of the vouchers value (or part thereof) not being spent at the Goffs UK Premier Sale.
- The awarding of the voucher is at the absolute discretion of Goffs

UK whose decision is final and binding.

The winning owner/owners will also receive Owners badges, lunch and a bottle of champagne on the table for up to six people on a raceday at York in the following 51-week period following their success in the Goffs UK Harry Beeby Premier Yearling Stakes:

- This prize will be awarded to the owner/owners of the winning horse as registered by Weatherbys as at the day of the race. In the event of a dead heat where more than one horse is confirmed as the winner, the prize will be split equally between the owner/owners of the confirmed winners (for example, if there are two winning horses the owner/owners of each horse will receive three spaces on the table).
- This prize is subject to availability. The winning owner/owners should notify Goffs UK of the race day on which they require the table as soon as possible to avoid disappointment.
- If the table is not taken during the 51-week period following their success in the Goffs UK Harry Beeby Premier Yearling Stakes, then the offer will become invalid.
- The awarding of this prize is at the absolute discretion of Goffs UK whose decision is final and binding.

The winning trainer will be given the opportunity to enter into a rental-free six-month lease of a Goffs UK branded 3.5t horsebox from Theault:

- This prize is only available to UK based trainers. If the winning horse is trained by a trainer based outside of the UK, the horsebox will be awarded to the trainer of

the highest placed 2YO that is trained in the UK (who shall be the winning trainer for the purposes of these terms).

- In the event of a dead heat where more than one horse is confirmed as the winner, this prize will be split equally between the number of confirmed winners (for example, if there are two winning horses each trainer will be given the opportunity to enter into a rental-free lease of the Goffs UK branded horsebox for three months).
- The winning trainer will be required to sign a lease agreement with Theault containing the terms and conditions that will apply to the rental-free lease.
- There will be no charge for the first 10,000 miles (or the relevant proportion of 10,000 miles in the event that this prize is split), after which there will be a charge of 30p per mile.
- The two-stall vehicle will be available for a six-month period from the 1 April that follows the Goffs UK Harry Beeby Premier Yearling Stakes (for example, the vehicle will be available from 1 April 2022 following the 2021 Goffs UK Harry Beeby Premier Yearling Stakes).
- This prize cannot be transferred by the winning trainer or redeemed by anyone other than the winning trainer.
- The awarding of this prize is at the absolute discretion of Goffs UK who's decision is final and binding.

**Definition:** the trainer is the person or persons named on the training license at the time of the Harry Beeby Premier Yearling Stakes.
