

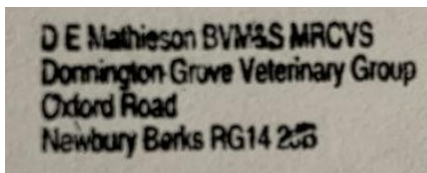

### **NOTE 2 - THE EXAMINATION**

The clinical examination is comprised of four parts:

- 2) Direct examination of the vulva and perineum.
- 3) Visual examination of the cervix and vagina using a speculum.
- 4) Palpation of the cervix and vagina per vagina.

Parts 3) and 4) do not form part of the standard examination of maiden mares / fillies.

If for any reason any part was omitted, the opinions expressed herein are based on that restricted examination. The reason for omitting any part and in what way the examination has been varied should be made clear on the certificate overleaf. For example, the temperament or condition (e.g. pregnancy) of the animal might make the procedure hazardous to perform.

Any additional diagnostic techniques, beyond the standard clinical examination, should be noted and the relevant findings recorded in the report section of the certificate overleaf or on a separate report to be appended to the certificate. Samples or swabs to be submitted for laboratory analysis may be required to fulfil sale conditions at some sales in which case the laboratory report should be appended to this certificate.

### **NOTE 3 - OPINION**

The opinion expressed overleaf is based solely on the clinical examination set out above at the time and on the day shown. It is given subject to the qualification that the animal may be suffering from a latent defect not discoverable in the clinical examination, and that the said animal may, at the time of the examination, have been subject to some previously administered drug or medicament having the effect of masking or concealing some disease, injury or physical abnormality that might otherwise have been clinically discoverable. Furthermore, the condition of the animal may have changed between the date of examination and the date of sale.
